## Trump: Take control of Fed Reserve from Powell

WASHINGTON

US President Donald Trump called for the Federal Reserve's board of governors to usurp the power of Fed Chair Jerome Powell, criticising the head of the US central bank for not cutting short-term interest rates.

Posting on his Truth Social platform, Trump called Powell "stubborn". The Fed chair has been subject to vicious verbal attacks by the Republican president for months.

If Jerome Powell doesn't "substantially" lower rates, Trump posted, "The Board should assume control, and do what everyone knows has to be done!'

Two of the 7 Fed governors, Christopher Waller and Michelle Bowman, said on Friday they see the tariffs as having a

one-time impact on prices and the job market as most likely softening. As a result, the two dissented at the Fed meeting on Wednesday and pushed for slight rate cuts relative to what Trump was seeking.

Even though Trump, who nominated Waller and Bowman, has claimed the US economy is booming, he welcomed their arguments and what he called their strong dissents. After the Fed announced later on Friday Governor Adriana Kugler will step down next week, Trump said Powell should follow her lead and

#### **US TARIFF TEMPORARY:**

TAIWAN PRESIDENT LAI The US has imposed a 20% tariff rate on goods from Taiwan, which is considered "temporary" by Taiwanese President William Lai, who expects negotiations to secure a lower rate, Taipei Taiwan reported.

The tariffs on semiconductors, electronics, and information technology products will determined separately under future US sectoral measures, as per Taipei Taiwan.

Taiwan, the US initially proposed a 32% tariff on its goods in April, later cut to 20%. However, Taiwan's tariff rate exceeds those of competitors like Japan and South Korea, which face a 15% levy. -ANI

India's Ambassador to the US Vinay Kwatra on Friday virtually inaugurated the new Indian Consular Application Centres (ICAC) in Boston, Columbus, Dallas, Detroit, Edison, Orlando, Raleigh and San Jose. An additional ICAC will soon open in Los Angeles.

Starting August 1, 2025, all consular services, including passport, visa, OCI, surrender

KABUL

Despite the 2020 Doha Agreement, Afghanistan remains a safe haven for major terrorist organisations including Al Qaeda, Tehrik-i-Taliban Pakistan (TTP), and ISIS-K, the US Special Inspector General for Afghanistan Reconstruction (SIGAR) has said in its latest quarterly report, warning of rising militant threats and worsening regional instability, Khaama Press reported.

Nearly four years after the Taliban's return to power, Afghanistan continues to spiral into insecurity, diplomatic isolation, and humanitarian collapse. According to Khaama Press, the SIGAR report noted the Taliban's harsh policies, especially restrictions targeting women and girls, have undermined its

"ISIS-Khorasan" was identified as the "largest transnational terrorist threat" emanating from Afghan soil, with SIGAR highlighting grave risks posed to ethnic and religious minorities, UN men, diplomats, and foreign nationals. Khaama Press reported rather than eliminating such groups, the Taliban has been accused of enabling

The report said the Taliban has continued its support for the TTP, which maintains 6,500 fighters in eastern Afghanistan. This alleged support not only violates the spirit of the Doha Agreement but reinforces fears Afghanistan could again become a launchpad for global terrorism, as per Khaama Press.

The humanitarian crisis has also intensified following the US decision to halt financial aid in April. Millions of Afghans have been left without life-saving assistance, the report warned. "Devastating impacts" have already been witnessed in vulnerable communities, the International Rescue Committee noted. Before the aid cutoff, the U.S. had contributed over \$30 mil-

lion to the UN's 2025 humani-

tarian response plan.

Khaama Press reported that diplomatic efforts have seen little progress. Talks between the Taliban and UN officials in Doha have stalled, as the group resists adopting international norms in exchange for economic relief. The U.S., meanwhile, has scaled down its engagement, limiting it to counterterrorism efforts and the repatriation of American citizens.

#### ओबीसी को 27 प्रतिशत आरक्षण का विरोध

परश्राम संगठन जाएगा सुप्रीम कोर्ट मोपाल,(निप्र)। मध्यप्रदेश में ओबीसी आरक्षण को लेकर एक बार फिर राजनीतिक सरगर्मी तेज हो गई है। कांग्रेस और बीजेपी में ओबीसी को २७ प्रतिशत आरक्षण देने को लेकर चल रही सियासी खींचतान के बीच अब परशुराम सेवा संगठन ने मोर्चा खोल दिया है। परशुराम सेवा संगठन के प्रदेश अध्यक्ष सुनील पांडे ने शनिवार को मीडिया से बातचीत में कहा कि ४ मई २०२२ को मध्यप्रदेश हाईकोर्ट जबलपुर ने ओबीसी आरक्षण बढ़ाने पर अंतरिम रोक लगाई गई थी। इस रोंक को हटाने के लिए प्रदेश सरकार ने सुप्रीम कोर्ट में याचिका दायर की है, जिसकी सुनवाई 5 अगस्त को होनी है। संगठन सुप्रीम कोर्ट से अनुरोध करेगा कि आरक्षण की वर्तमान विसंगतियों को समाप्त किया जाए ताकि सभी वर्गों के साथ समान न्याय हो। पांडे ने बताया कि फिलहाल राज्य में अनुसूचित जाति (एससी) को १६प्रतिशत, अनुसूचित जनजाति (एसटी) को २० प्रतिशत, अन्य पिछड़ा वर्ग (ओबीसी) को १४ प्रतिशत और आर्थिक रूप से कमजोर वर्ग (ईडब्ल्युएस) के तहत सवर्णों को १० प्रतिशत आरक्षण दिया जा रहा है। उन्होंने कहा कि ईडब्ल्युएस का आरक्षण ५० प्रतिशत की अधिकतम सीमा में नहीं जोड़ा गया है, जबिक ओबीसी आरक्षण को बढाकर २७ प्रतिशत करने का प्रयास संविधान पीट द्वारा तय की गई 50 प्रतिशत सीमा का उल्लंघन करता है। उन्होंने तर्क दिया कि सुप्रीम कोर्ट ने पहले ही स्पष्ट किया है कि 50 प्रतिशत से अधिक आरक्षण देने के लिए राज्य सरकार को असाधारण परिस्थितियों के समर्थन में ठोस और वैध डेटा प्रस्तत करना होगा, जो अब तक नहीं किया गया है। जब तक यह प्रमाणित नहीं होता, तब तक हाईकोर्ट की लगाई गई रोक लागू रहनी चाहिए।
