इंटेर । इस्टाप्सी इलाके में शोमवार देर रात एक फोटो स्टुडियो और गिपट गैपरी की दुछान में भीष । उपन लग गई। अजनमी में स्टुडियो का पूरा सेटउप, फैमरे और निपट आइटम मलकर खाक से गए। अज से लाखों रूपए का बुकसान होने की अतर्वका है। खानीच लोगों के मुताबिक, आग लगने के काफी देर बाद भी फायर ब्रिगेड की गाड़ियां मौके पर नहीं पहुंची। करीब एक घंटे तक लोगों ने खुद ही आग पर काबू पाने की कोशिश की। इस वैरान द्वारकपुरी पुलिस और स्थानीय रहवासी निलकर दुकान का शटर तोड़कर सामान बाहर निकलने में जुटे रहे। द्वारकापुरी पुलिस के मुताबिक, घटना अंकल गली, 60 फीट रोड पर स्थित एसआर स्टूडियो और पर्सनालिस्ट गिपट सेंटर की है। आग लगते ही दुकान से धुआं निकलने लगा, जिससे आसपास अफरा-तफरी मव गई। सूचना पर टीआई सुशील पटेल अपनी टीम के साथ मौके पर पहुंचे और स्थानीय लोगों की मदद से बोरिग से पानी डालकर आग पर काबू पाया। आग लगने के बाद इलाके की बिजली चली गई। जिससे पूरे द्वारकापुरी क्षेत्र में काफी देर तक अंधेरा छाया रहा। फायर ब्रिगेड की गाड़ियां करीब एक घंटे बाद घटनास्थल पर पहुंची, तब तक स्थानीय लोगों और पुलिस की मदद से आग काफी हद तक बुझाई जा चुकी थी।

'Victorious' Jarange breaks down after ending 5-day fast

PTI MUMBAI

Activist Manoj Jarange on Tuesday evening ended his five-day-old fast after the Maharashtra government accepted most of his demands, including granting eligible Marathas Kunbi caste certificates which will make them eligible for reservation benefits available to OBCs.

Jarange accepted a glass of fruit juice offered by senior BJP minister Radhakrishna Vikhe Patil, who heads the cabinet sub-committee on Maratha reservation, and other members of the panel at south Mumbai's Azad Maidan, the site of his agitation since August 29, marking the end of his fast.

He later left Azad Maidan in an ambulance for medical check-up.

Before ending his hunger strike, Jarange declared victory after a delegation of senior minister, including Vikhe Patil, met him at the protest site and conveyed acceptance of his demands, including giving Kunbi caste certificates to eligible Marathas.

The announcement of victory triggered wild celebrations among his supporters.

The activist warned against the BJP-led government reneging on its promises.

"I warn Vikhe Patil if there is any attempt to deceive us on implementation of the Government Resolution (GR) on implementation of the Hyderabad gazette, in which a three-member committee will be set up at village level, and promises like providing jobs to the kin of Maratha activists who lost their lives in protests, withdrawal of cases against protesters, we will not keep quiet. I will come to Vikhe's home and sit there till I die,' Jarange cautioned.

Talking to reporters in Nagpur, Fadnavis hailed Jarange's move to call off his fast and asserted his government has found a solution in the interest of the Maratha community.

The CM said the government told protesters caste certificate can be given to individuals and not the community.

"My objective was to give justice to the Maratha community. My government was always focused on the welfare of Marathas and I will continue to work for all communities in Maharashtra, be it Marathas or OBCs," Fadnavis

For over a century and a half, the sight of a postman knocking at the door with a registered envelope carried weight. It meant a government order, a court notice, an appointment letter, or sometimes a long-awaited personal message. That chapter in India's communication history has now formally closed.

The 171-year-old registered post service, introduced during the British period, has been discontinued from September 1. The postal department has merged it with Speed Post, which is faster, trackable, and considered more reliable but also more expensive.

Registered post was once synonymous with trust. It

was the preferred mode for government departments, courts, banks, and even ordinary citizens who wanted assurance that their letters reached safely.

A stamped acknowledgement slip, known as the AD card, gave senders peace of mind. In villages, a registered envelope was enough to draw a crowd, as it usually carried official communication.

But with the advent of digital platforms such as email, WhatsApp and instant messaging, the demand for registered post dwindled sharply.
