BIDEN FOR 'PAUSE'

Says "I am the guy" who convinced both Netanyahu and Sissi to allow aid into Gaza

President Joe Biden said he thought there should be a humanitarian 'pause' in the Israel-Hamas war, after his campaign speech on Wednesday evening was interrupted by a protester calling for a cease-fire.

The call was a subtle departure for Biden and top White House aides, who throughout the Middle East crisis have been steadfast in stating they will not dictate how the Israelis carry out their military operations in response to the October 7 attack by Hamas.

In his comments, Biden was exerting pressure on Israeli Prime Minister Benjamin Netanyahu to give Palestinians at least a brief reprieve from the relentless military operation that's left thousands dead and mired the 141-square-mile strip in a rolling humanitarian crisis.

White House National Security Council spokesman John Kirby said earlier on Wednesday that Biden's newly confirmed ambassador to Israel, Jack Lew, would soon

be dispatched to the Middle East and would be tasked in part with "supporting US efforts to create the conditions for a humanitarian pause to address the worsening humanitarian conditions facing Palestinian civilians."

Israeli Ambassador to the US Michael Herzog told "The Hill" on Wednesday "we don't need urging" in response to calls for more aid for Gaza. "We

are ramping up humanitarian supplies into Gaza in those areas which are away from Hamas in the southern part of Gaza. The number of truckloads doubles and is going to pick up more and more," he said. "We provide water. We provide other types of supplies." He said to NewsNation they were happy to see foreigners leave Gaza. On Wednesday evening,

Biden was speaking to a crowd of supporters in Minneapolis about his reasons for running for president in 2020 when a woman got up and yelled, "Mr. President, if you care about Jewish people, as a rabbi, I need you to call for a cease-fire." His presence in the city drew more than 1,000 demonstrators not far from where the fundraisers were held, and they carried Palestinian flags and signs that said 'Stop Bombing Children', 'Free Palestine' and 'Ceasefire now.'

Biden said, when asked, that a pause "means give time to get the prisoners out." White House officials later clarified he meant hostages and humanitarian aid. "This is incredibly complicated for the Israelis," Biden went on. "It's incredibly complicated for the Muslim world as well. ... I supported a two-state solution, I have from the very beginning. The fact of the matter is that Hamas is a terrorist organization. A flat-out terrorist organisation," he said. But Biden noted that he's been working on humanitarian aid, saying he was the one who convinced both Netanyahu and Egyptian President Abdel Fattah el-Sissi to allow aid into Gaza. "I'm the guy," he said.

Cornell student arrested

Cornell University, the epicentre of antisemitic threats, canceled classes for Friday citing "extraordinary stress" on its campus as one of its students was arrested and accused of making violent antisemitic threats against Jewish people at the college. University authorities acknowledged that there was palpable unease over the raging Israel-Hamas war. The university may opt for online classes, authorities said.

Patrick Dai, 21, a junior student was arrested and federally charged in connection with a series of on-line posts over the weekend which threatened to kill and harm Cornell's Jewish students, New York

prosecutors say. Dai appeared in federal court on Wednesday but did not enter a plea. He was remanded back into the custody of US marshals.

He is accused of publishing the posts, in which he threatened to kill and injure Jewish people on campus and "shoot up" the university's predominantly kosher dining hall, according to the US Attorney's Office for New York's Northern District.

In one post, Dai wrote he would "bring an assault rifle to campus" and shoot Jewish people, according to prosecutors. In addition to the online threats, the university also received a "concerning crime alert" on Wednesday, Cornell president Martha Pollack said in a

statement. Though the alert was unsubstantiated, it "adds to the stress we are all feeling," she wrote.

The threats against Cornell's students prompted state and campus police to bolster their presence on campus, where about 22% of the student body is Jewish, according to the school's Hillel organisation.

ANTISEMITIC THREATS

While we take some measure of relief in knowing that the alleged author of the vile antisemitic posts that threatened our Jewish community is in custody, it was disturbing to learn that he was a Cornell student," Pollack said. Dai's father told the Post that his son had stopped responding to calls and texts days before his arrest and around the time the threatening posts were published.

Saudi Arabia launches relief campaign

Saudi Arabia has launched a campaign to raise relief funds for Palestinians in the Gaza Strip. The state-run Saudi Press Agency reported on Thursday that King Salman has donated about \$8 million to the fund and Crown Prince Mohammed bin Salman has donated over \$5 million.

Pak to go to polls on Feb 11

Pakistan's general elections will be held on February 11 to elect a new government, the top electoral body on Thursday told the Supreme Court, ending uncertainty over the polls and strengthening the country's position in review talks with the IMF for the release of \$710 million second tranche of a loan.

The Election Commission of Pakistan (ECP) told the Supreme Court about the date during a hearing of a set of petitions calling for holding elections within 90 days after the dissolution of the National Assembly and the provincial legislatures. Last month, the ECP announced that elections would be held in January 2024.

A three-judge bench comprising Chief Justice Qazi Faez Isa, Justice Amin-ud-Din Khan and Justice Athar Minallah took up the pleas moved by the Supreme Court Bar Association (SCBA), Pakistan Tehreek-e-Insaf and others. The ECP had announced earlier that 54 days were needed to hold elections after the completion of the delimitation exercise by November 30.

UN: Strikes on refugee camp could amount to war crimes

Deadly Israeli air strikes on the Gaza Strip's largest refugee camp 'could amount to war crimes', the UN Human Rights Office said on Wednesday.

Israeli strikes have targeted the Jabalia refugee camp twice in two days, killing and wounding dozens, according to the health ministry in the Hamas-run Palestinian territory. Israel said Tuesday's raid was a successful hit on top Hamas commander Ibrahim Biari. "Given the high number of civilian casualties and the scale of destruction following Israeli air strikes on Jabalia refugee camp, we have serious concerns that these are disproportionate attacks that could amount to war crimes," the office wrote on X, formerly Twitter.

Israel has relentlessly pounded Gaza in retribution for the worst attack in the country's history. APFTV images from Wednesday's strike on the camp showed extensive damage and rescuers clawing through rubble to extract blood-stained casualties.

UN chief Antonio Guterres is "appalled over the escalating violence in Gaza, including the killing of Palestinians, including women and children in Israeli air strikes in residential areas of the densely populated Jabalia refugee camp", his spokesman Stephane Dujarric said on Wednesday.

QUICK TAKES

GAZA'S LARGEST HOSPITAL STRUGGLES TO TREAT INJURED

The Gaza Strip's largest hospital is on its last supply of fuel as it struggles to cope with hundreds of wounded people while hosting thousands of displaced Palestinians in the Hamas-Israel war, a senior doctor said. "The high number of displaced people are no longer living in the courtyard of the hospital but are also living inside the hospital, including the corridors," UK-based charity Medical Aid for Palestinians quoted Shifa Hospital's chief of surgery, Dr. Marwan Abusada, as saying. Abusada warned that illnesses can spread because of poor conditions.

POWER GENERATOR OUT OF SERVICE AT KEY HOSPITAL

The main power generator in the northern Gaza Strip's key hospital went out of service early Thursday, Gaza's Health Ministry said. The Indonesian Hospital in Beit Lahia is near densely populated Jabalia refugee camp, which has been the target of Israeli air strikes this week. Health Ministry spokesperson Ashraf Al-Qudra said in a televised statement that the hospital is running on a smaller backup generator but had to turn off lights in most rooms, shut down oxygen generators and resort to oxygen cylinders, and turn off mortuary refrigerators.

GERMANY IMPOSES A BAN ON PRO-HAMAS ACTIVITY

Germany's top security official says she has implemented a formal ban on activity by or in support of Hamas and is dissolving a group that was behind a celebration of Hamas' attack on Israel. Chancellor Olaf Scholz had on October 12 announced that the government planned to take action against two groups. Interior Minister Nancy Faeser said she is putting the ban on activity related to Hamas, which is already listed by the European Union as a terrorist group, into effect on Thursday. She said she is banning and dissolving the German branch of the Samidoun network, which she said 'supports and glorifies' groups including Hamas.

Ground troops advance

Israel Defense Forces (IDF) Spokesperson Daniel Hagari said on Thursday that the Israeli forces continue to advance in Gaza as per plan. "The IDF continues to advance in the Gaza City, conducting face-to-face battles with Hamas and deepening the fighting. The battle is progressing as we have planned," IDF Spokesperson Daniel Hagari said.

Israeli forces launched an expanded ground invasion on last Friday calling it the "2nd stage" of war against Hamas and have since made "significant" advances into the Gaza. "We are located at the gates of Gaza City," said Brig General Itzik Cohen, commander of the 162nd Armored Division. Meanwhile, US State Department Spokesman Matthew Miller said that about 400 US citizens are seeking to leave the territory immediately, taking the total to more than 1,000 if you included their family members also, USA Today reported.

On Wednesday, the officials from Australia, Bulgaria, France, the UK and the U.S announced the first list of Gaza via Rafah border to Egypt.

We have reviewed the accompanying statement of unaudited financial results ('the Statement') of Ad-Manum Finance Limited ('the Company') for the period ended 30 September 2023 being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), including relevant circulars issued by the SEBI from time to time.
